

## BIATHLON AUSTRALIA TRAVEL AND CONSENT FORM

Biathlon Australia Limited (BA) athletes and Authorised Officers may travel extensively for both training and competition. BA endeavours to source accommodation where athletes and / or authorised officers of the same gender will share accommodation. On occasion, availability and / or style of accommodation may be restricted and as such, it may not be practicably possible for same gender share arrangements. In such circumstances, BA may request athletes and authorised officers to stay in mixed gender accommodation (please note: mixed genders will not be allocated a shared bedroom).

## Participants under 18 years of age

BA will arrange, where possible for persons under the age of 18, to:

1. travel / be transported with a group of team members; share accommodation with a group of team members who are of the same gender and similar age.

At times, this may not be practicably possible and as such, BA seeks parent/guardian approval in writing for participants under 18yrs of age to:

- 2. travel to / from a specific sporting location with only one authorised officer over the age of 18; and
- 3. share accommodation with team member(s) / authorised officers who may be over the age of 18.

## **CONSENT** (for athletes under 18yrs only)

As participants, both under and over 18yrs of age, you understand and agree that when sharing accommodation:

- 1. there is no mixed gender sharing of bedrooms;
- 2. preferably there is no sharing of beds but acknowledges this may not always be possible due to accommodation bedding configuration;
- 3. there is an expectation that all members within the shared accommodation will respect each other's privacy, personal belongings and space;
- 4. they will be aware of other participants training / competition schedules and will keep evening noise to an appropriate level;
- 5. should an athletes under 18yrs feel uncomfortable with any travel/transportation/accommodation arrangements, they must inform their Coach and/or a BA Authorised Officer immediately.

- 6. should any of the abovementioned conditions be breached, disciplinary measures may be enforced; and
- 7. I acknowledge the requirements of the BA Travel Policy, and in particular Clause 15, and other policies of BA as listed on the BA website.

## COVID-19

- 1. I acknowledge COVID19 is a risk in the country (s) I am going to as part of the 2022-23 BA Overseas Program;
- 2. I will follow the COVID19 protocols for 2022-23 BA Overseas Program including isolation requirements in the event of a positive PCR/RAT test; and
- 3. I will ensure I have organised certificates, tests and entry paperwork requirements (whether in hard-copy or online), I need to enter each country for the Overseas Program and will be responsible for any costs incurred if I am unable to enter a country due to lack of required documents.
